Any personal data that you provide to us or supply during the process of downloading our mobile application will be held by Thorntons in confidence and in compliance with all applicable legal and regulatory requirements relating to the obtaining, retention, processing and use of personal data. We comply with the provisions of the General Data Protection Regulation requirements applicable to electronic communications and aim to maintain consistently high levels of best practice in our processing of personal information. We are the Data Controller for the purposes of your personal information that we collect.

No personal information will be divulged to anyone or any organisation except Thorntons. We may use your personal details for the following purposes: to register you for customer communication from Thorntons once you have opted in, to register you for Thorntons services at your own request; to administer your account and contact you in relation to if; and, if you have opted in, to contact you with details of Thorntons products and services which we believe would be of interest to you.

Certain statistical information is available to us via our internet service provider through the use of cookies. A cookie is a piece of information which a website stores through the web browser on your PC that it can later retrieve when you log back on to the website. This information may include the logical address of the server you are using, the top level domain name from which you access the internet (for example .ie, .com, .org), the type of browser you are using, the date and time you access the site, the internet used to link to our site.
